Background

This agreement is signed as per the request of the 1st party; to enable the 1st party's institute i.e Markaz Arts and Science College, Karthala (P.O), Athavanad, to fulfill the need of the laboratory facilities to their students of Chemistry Department by availing the Physical and Chemical Testing facilities available in the 2nd party's institute i.e Common Facility Service Centre, Manjeri (herein after called CFSC). Following terms & conditions are incorporated in this agreement as mutually beneficial.

General Terms and Conditions

Provided by CFSC

- Facilities of the Chemical Testing Laboratory at CFSC
- Facilities of the Physical Testing Laboratory at CFSC
- Guidance and Supervision to use the lab equipments

Provided by the Markaz Arts and Science College, Athavanad

- Faculty support from the Department of Chemistry, Markaz Arts and Science College, Athavanad shall provide for the training activities at CFSC on request from the 2nd party.
- Provide advice on chemistry subject to the 2nd party whenever the requested.
- Written request along with the bona-fide is to be forwarded to the 2nd party before at least two working days to avail the instruments facilities at CFSC.
- Fees stipulated if any; should be paid in advance as per the government directions time to time.

Other Terms and Conditions

Any misconduct or behaviour from the students or staff of the Markaz Arts and Science College, Athavanad during the period of availing instrumental facilities at CFSC will result the cancellation of this agreement without prior notice to the 1st party.

Duration

This MOU shall become effective upon signature by the authorized officials under the mentioned and will remain in effect until modified or terminated by any one of the parties by mutual consent. However, as the Head of the department of the Industries & Commerce of Kerala State; the Director of Industries and Commerce, Kerala State has the power to cancel this MOU at any time without notice.

This memorandum is a statement of intent by the parties, intended to encourage mutual co-operation and does not create any rights, obligations or duties for any parties.
