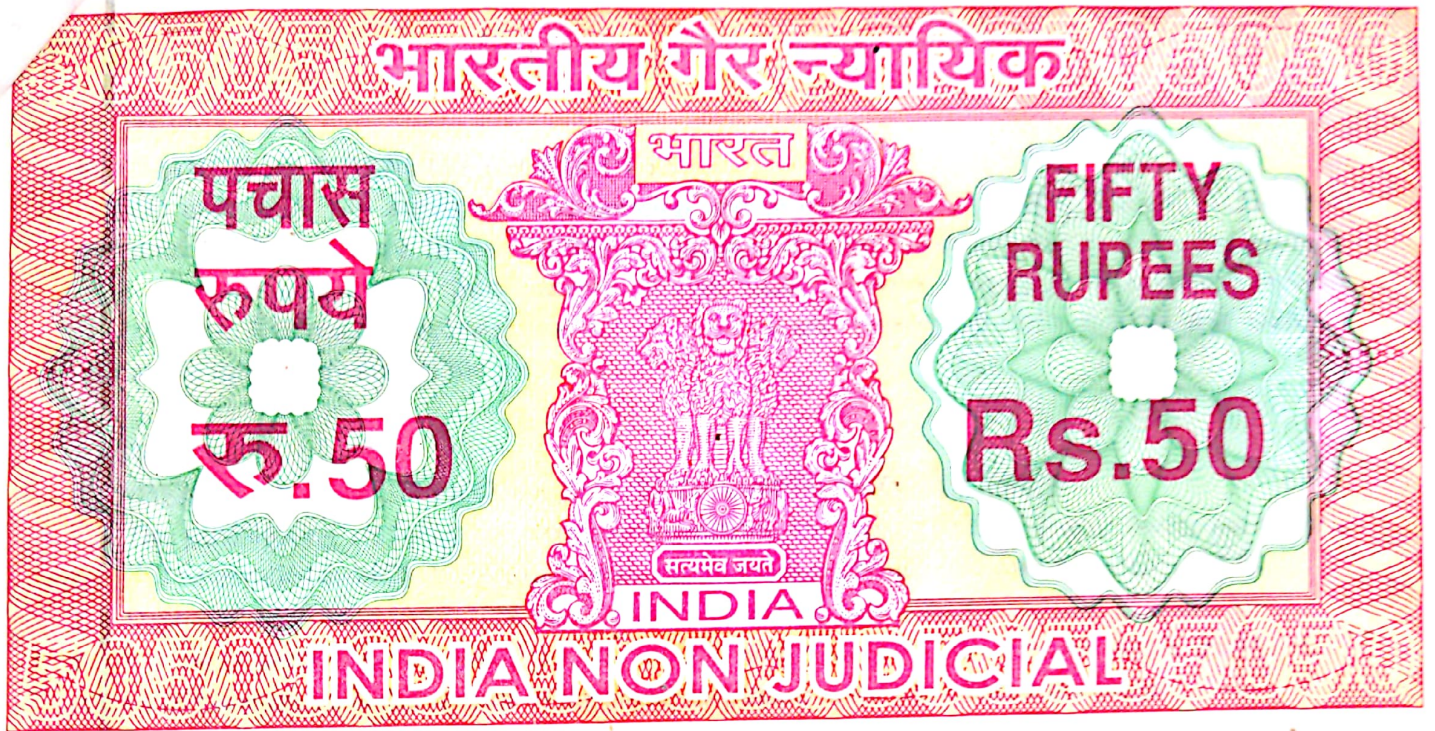

The two institutions in the Memorandum of understanding will be ALBIO TECHNOLOGIES, KOCHI and DEPARTMENT OF BIOCHEMISTRY, MARKAZ ARTS AND SCIENCE COLLEGE, ATHAVANAD. ALBIO TECHNOLOGIES, KOCHI is an ISO certified Testing and Research laboratory located in Kalamassery, Kochi-22. DEPARTMENT OF BIOCHEMISTRY, MARKAZ ARTS AND SCIENCE COLLEGE, ATHAVANAD is affiliated to University of Calicut, Kerala.

ARTICLE I

FIELD OF CO-OPERATION

Co-operation between the two institutions may be established within any field related to Science and Technology of mutual interest and in particular in the field of Academic research, faculty/ students training and dissemination of knowledge to the students of Dept. on a long term basis.

ARTICLE 2

EXCHANGE OF SCIENTIST OR FACULTY

ALBIO and Dept. will encourage collaboration and research area of mutual interest. ALBIO will welcome Teachers of Dept. to visit ALBIO to engage in Academic research and training. Reciprocally, Dept. will welcome faculty from ALBIO to visit Dept. in order to engage in scientific research programmes. Proposals concerning the topics, persons and periods of visits will be sent within a reasonable time in advance of the proposed visit.

ARTICLE 3

ACADEMIC RESEARCH PROJECTS AND TRAINING PROGRAMMES

1. The participating students will continue as students for Degree of their parent institution (Dept.), and will be enrolled as affiliate (or non-award, non Degree) students in the host institution (ALBIO).
2. Dept. will encourage students to join ALBIO for carrying out of their Academic projects.
3. For every student under course programme the host institution will send academic project work reports of the students in the courses to the parent institution at the end of the tenure/term.
4. Each student will be send by the Dept. for the course programme for a mutually approved duration of time.
5. The Dept. will nominate students for the academic programme, and forward relevant data concerning the students to the host institution. The host institution will decide on the acceptability of the students nominated, and identify an appropriate supervisor. It is expected that the host institution will accept the nomination except in extra ordinary circumstances; and in such cases the parent institution will submit another application for consideration.
6. Every student under the programme shall pursue their research programme which is developed in consultation with the parent institution, and which is not in conflict with the regulations of the host institution. The appointed supervisor at the host institution will provide a report to the parent institution on completion of his/her tenure/term. However, the two supervisors will jointly guide the students, until they complete their theses and are awarded degree.
7. Project fees of students have to be paid to the host institution, before the start of training & academic project and no fee needs to be paid at the parent institution.
8. The faculty concerned of the Dept. will be responsible for arranging the study programme of the student.
9. ALBIO will provide various training programme for the benefit of students in the Dept for a fees mutually agreed upon by the two institutions in the Dept. premises. The Dept. shall provide a space and other amenities for providing such training programme and the Faculty and course material will be provided by ALBIO.
10. Efforts will be made by both the institutions to share information's about ongoing research activities in order to establish contacts and collaborations between professionals working within the same field.
11. The two institutions shall initiate and exchange research publication list and other publications relevant to the project.

ARTICLE 4


MANAGEMENT AND ADMINISTRATION:

1. Negotiation, implementation and co-operation of the memorandum of understanding fall under the responsibility of Director of ALBIO TECHNOLOGIES, KOCHI and Principal, MARKAZ ARTS AND SCIENCE COLLEGE, ATHAVANAD.
2. Issues about specific activities including rights and obligations of each party shall be notified or communicated to the offices mentioned above.
3. The contact person mentioned above can nominate a member of the staff from within their institutions to coordinate activity.
4. This memorandum of understanding shall have duration of two years renewable for another two years, unless either party give notice of termination not later than three months prior to the expiration of the existing memorandum of understanding. However, either party can ask to terminate by giving notice of termination not less than three months.
5. The memorandum of understanding will take effect upon ratification by the Director of ALBIO TECHNOLOGIES, KOCHI and Principal, MARKAZ ARTS AND SCIENCE COLLEGE, ATHAVANAD.
