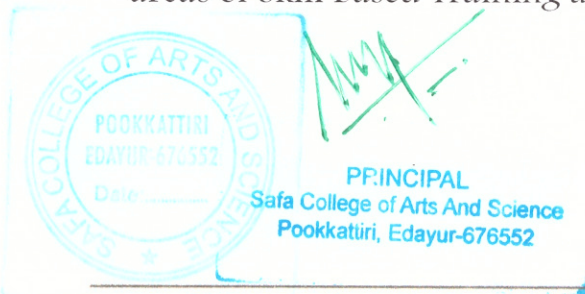

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

#### CLAUSE 1 : CO-OPERATION

- Both Parties are united by common interests and objectives, and they shall establish channel of communication and co-operation that will promote and advance their respective operations within the Institution. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities

#### CLAUSE 2 : SCOPE OF THE MoU

- The budding graduates from the institutions could play key role in knowledge up gradation, Innovation and competitiveness of the industry. Both parties believe that the close cooperation between the two would be of major benefit to the student community as well as the faculty to enhance their skills and knowledge
- Execution: Both parties are responsible to arrange the webinar sessions by providing the resource persons.
- There is no financial commitment on the part of the First Party and Second party. If there is any financial consideration, it will be dealt separately

#### CLAUSE 3: VALIDITY

- This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms.
- Both Parties may terminate this MoU upon 30 calendar days notice in writing. In the event of termination, both parties have to discharge their obligations.

#### CLAUSE 4: RELATIONSHIP BETWEEN THE PARTIES

- It is expressly agreed that First Party and Second Party are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the Party.



The agreement will take effect from the date of its signing and shall be valid for a period of Two years from that date unless sooner terminated, revoked or modified by mutual written agreement between the two parties and may be extended by mutual written agreement.
